One United Properties is one of the largest and most successful green developers of residential, mixed-use, and office real estate in Bucharest, Romania. One United Properties has officially entered the Bucharest Stock Exchange Market. The company's shares began trading on the Main Market, under ONE symbol, on July 12th. Therefore, the company became the third-largest Romanian entrepreneurial company listed on the Bucharest Stock Exchange and entered the top 10 listed companies, according to the IPO market capitalization.

Capital Partners was the no.1 independent investment banking company in Romania between 2005-2016. The company has advised and closed transactions in excess of USD 2.0 billion in its almost 11 years of activity, and was acquired in March 2016 by Banca Transilvania, thus becoming BT Capital Partners.
